- Water pressure 100 psi
- Can tap force main with saddle tap
- Waste water plant has plenty of capacity for camping / restaurants
- City has equipment available to let park use (need to work out an agreement)

Weaknesses

- State Highway 117 traffic – someday may need 3rd lane
- Widening may encroach on ditch
- Average Colfax income is \$29K
- Businesses leaving

Weaknesses

- No full-time maintenance staff

Opportunities

- Fishing Club (Sportsman Club of Iowa) – Modeled after Isaac Walton League
- Brant has had 239 signatures as potential members at \$1,000/year (as far away as Twin Cities)
- Lease payment schedule for first 5 years (based on 300 members) – 25% of membership gross (\$75,000)
- 5 Yr. Total = \$375,000
- Envision maximum of 300 fishing members with no limit on social members

- Profit center for the park
- Club members as stewards (keep it clean and maintain)
- Help establish fishing regulations and limits
- Club to provide an annual re-stocking program
- Fishing Lodge (3-5 yr plan) Supported by club members
- Funding source for maintenance
- Not all members want to fish, some just want a lodge / restaurant (funded and built by Club)
- Restaurant would be open to public with full bar service
- Fishing tackle and bait shop
- Fish cleaning stations
- Club would have exclusive boat access to north and east lakes (public could be allowed shore access on these)
- West lake would be open to public for boat access
- Cabins
- Beach
- Food / drink
- Crafts – Iowa style or Amana style
- Retail on site helps with security and maintaining site

Concerns

- Money
- Re-stocking (need private hatchery because of flooding potential)
- Trash
- Lake nutrients & habitat
- Lack of rules and standards
- Grants – Do restrictions on lake access limit grant opportunities?
Can you use money from club as matching funds?
- Fish management – is it a solution and can pay for improvements?
- Limited access to fishing (Limits and rules)
- Board is not full support on fishing (may be convinced)

 - Provide a .5 to 1-mile accessible loop and for interstate travelers to stretch
- Campground is a must for revenue
- Cabins (County cabins are booked every weekend)
- Clean out invasive plants
- Isolate camping from rest of park
- Park design something in between Gray's Lake and Rock Creek
- Gravel riding
